WHAT DOES CPS ENERGY BUY?







- Commodities (direct inputs, hardware, tools, safety equipment)
- Services (consulting, engineering, janitorial, IT, staffing, construction)

PROCUREMENT THRESHOLDS



- Competitive Solicitations:
 - \$25,000 to \$50,000: use of abbreviated solicitation process where a minimum of two small, local or diverse companies are solicited
 - <u>\$50,000</u> and <u>greater</u>: require advertisement and sealed competitive solicitation process

SOLICITATION METHODS



- Request for Quotation
 - Commodities
 - Generally evaluated on price
 - Request for Proposal
 - Qualifying factors, Evaluation Criteria
 - Best value determination set forth in RFP
 - Request for Qualification
 - Professional Services

Insurance/Bonding requirements vary based on risk associated with the services being solicited

SOLICITATION INFORMATION



- All communication associated with a respective solicitation must be directed to the Procurement Agent responsible for that activity
- The responses are summarized and objectively evaluated based on the type of solicitation
- Evaluation incentives from small/diverse and local businesses are applied
